Barb Dayton reported that there is a large increase in the number of late start classes, and about 1/3 of them end up being taught by prorata. She will pursue this topic with Tom Hamel, because it does put adjuncts at a disadvantage, since we don't find out until the last minute that the class has low enrollment.

Facilities Master Plan

Information about the plan for Classroom Remodeling, the Science and Health Careers Instructional Building, the Des Plaines Enrollment Center and Student Gathering Space can be found at http://www.oakton.edu/about/ourlocations/facilities_plan/implementation/.

At the recent Board of Trustees meeting the members heard an update from Legate Architects on the new Science and Health Careers building. The building will be 3 floors, the first floor will consist of 25,000 square feet, the second floor will be 30,000 square feet and the third floor will be 35,000 square feet.

The Board was shown aerial views of how Oakton will look once the entire project including the enrollment center and the student center are completed. Consult the above mentioned website for details.

Chicago Teacher's Union

Thursday, October 20, 2011 the state Labor Relations Board voted in favor of the Chicago Teachers' Union and asked the state attorney general's office to seek an injunction to prohibit more Chicago city schools from lengthening the school day. "The labor board's decision asked the courts to prevent Chicago Public Schools from negotiating longer school days directly with teachers and principals; to stop the practice of offering financial incentives to employees who vote in favor of the longer day; and to cease and desist from unilaterally modifying terms of the existing teachers' contract".

The Administration offered individual teachers a 2% salary bonus and individual schools \$150,000 if they would vote to opt out of their existing contract and adopt a longer school day this year.

Essentially what the Administration did was subvert the existing contract by going directly to individual teachers and principals and offering them "incentives" to vote for a longer school day. The Teachers'

Union has told the Administration it will not support a longer school day in 2011-2012. A new state law will allow the school district to set a longer school day in 2012-2013.

How To Get Paid for Those Serving on Committees:

- 1- Get a substitute form from your division office.
- 2- After each meeting of your committee record the date, number of hours the committee met at \$30 per hour.
- 3- At the end of the semester, or when your committee disbands, whichever comes first, total the number of hours you spent on the committee and get it signed by the chair of your committee.
- 4- Submit your form to the secretary in your division who does payroll.
- 5- Check on-line to make sure that you were paid (give it two pay periods).
- 6- Thanks for supporting the AFA and making a contribution to Oakton.

National Labor Relations Board (NLRB) issues complaint against Columbia College

The National Labor Relations Board (NLRB) has issued a complaint against Columbia College. NLRB alleges that Columbia College committed the following illegal activities and has issued a complaint against Columbia College Chicago on three key charges:

- The College "has been failing and refusing to bargain collectively and in good faith...."
- The College "has been interfering with, restraining, and coercing employees...."
- The College "has been discriminating in regard to the hire or tenure or terms or conditions of employment of its employees, thereby discouraging membership in a labor organization...."

The General Counsel of the NLRB has further sought an order requiring the College to make whole all affected employees, and to provide all other relief as may be just and proper to remedy the alleged unfair labor practices.

A hearing date has been scheduled for Dec. 13, 2011 to decide the charges.

P-fac remains committed to negotiating a fair contract.
