

New Four-Year Contract Negotiated

After a year of difficult work, the AFA negotiating team has reached a four year agreement with the college. The college's Board of Trustees ratified the contract at its August 18th meeting, and the next steps are for the union membership to learn details of the contract and to vote on its acceptance.

Rules preclude a discussion of the contract's provisions here, so your attendance at one of three upcoming forums is important.

MEETINGS ON THE CONTRACT

The contract's provisions will be explained at three meetings. On the Des Plaines campus, members are encouraged to come to Room B in the Business Conference center on Tuesday, September 8 at either 12:15 or 5:00.

On the Skokie Campus, on Wednesday, September 9th, a meeting will convene at 12:30 in room A151.

All Oakton part-time instructors owe gratitude to our negotiating team for their commitment and endurance, especially over long summer hours, that resulted in this new contract. The negotiating team, , Barbara Dayton, Beverly Stanis, and Larry Cohen, has recommended a "Yes" vote to ratify the contract.

Voting on the Contract

Voting to ratify the contract will take place on Wednesday, September 9th and Thursday, September 10th. Ballot boxes will be located in each Division office in Des Plaines and in the Faculty Support Office on the Skokie campus. AFA members may vote until the closing times of these offices.

To vote, please legibly sign the check-in sheet located

at each box. Then, take a ballot, mark it, and place it in a small envelope. Place this smaller envelope inside a larger envelope and sign the larger envelope. Place the double-enveloped ballot into the box.

All materials and instructions will be at each box. This method should ensure secrecy and accuracy.

A Dues Note

If you are a member who teaches at another school and pay dues to another NEA/IEA affiliated union, please let us know. Your dues may be reduced to just local dues here.

On an associated note, the AFA board has voted on this year's dues and has managed to keep dues to 95 dollars per semester.
